Key words

Louisiana Purchase	The 1803 deal in which the United States bought 828,000 square miles of land from France for \$15 million. It doubled the size of the country and added all or part of 15 future states.
Twelfth Amendment	The 1804 constitutional change requiring electors to cast separate ballots for president and vice president. Replaced the original two-ballot rule that had caused the 1796 split-party administration and the 1800 Jefferson-Burr tie.
Burr-Hamilton duel	The July 11, 1804 duel in which Vice President Aaron Burr killed Alexander Hamilton, the Federalist Party's organizing genius. The scandal hurt Federalist morale just four months before the election.
Lewis and Clark Expedition	The 1804-1806 exploration team Jefferson sent to map the Louisiana Purchase and find a route to the Pacific Ocean. Their expedition is one of the most famous in American history.
Landslide	An election won by a huge margin. Jefferson's 162 to 14 victory in 1804 is one of the biggest landslides in U.S. presidential history.

QUESTION 1

162. Jefferson won 162 electoral votes; Pinckney won 14 - one of the biggest landslides in U.S. history. Jefferson won 92 percent of the Electoral College.

Jefferson carried every state except Connecticut, Delaware, and two of Maryland's 11 electors.

QUESTION 2

The Louisiana Purchase doubled the size of the United States. France sold the U.S. 828,000 square miles of land for \$15 million. The new territory eventually became all or part of 15 states. It also gave the U.S. control of the Mississippi River and the port of New Orleans.

The Louisiana Purchase is one of the largest land deals in history. It transformed the United States from an Atlantic seaboard nation into a continental power.

QUESTION 3

The Twelfth Amendment was a new rule requiring electors to cast separate ballots for president and vice president. It was added because the original two-ballot rule had caused the 1796 split-party administration and the 1800 Jefferson-Burr tie. The amendment was ratified June 15, 1804.

The Twelfth Amendment is the first constitutional amendment written to address specific recent electoral failures. It is still the rule used today.

QUESTION 4

Alexander Hamilton, the Federalist Party's organizing genius, had been killed in a duel by Vice President Aaron Burr on July 11, 1804 - just four months before the election. Hamilton's death left the Federalists without their key strategist. The party also could not match Jefferson's popularity, the Louisiana Purchase, and the tax cuts. The Federalists would never win another presidential election.

The Federalist Party effectively collapsed as a national party after 1804. Their last credible national campaign was in 1816; after that they disappeared.
