Republican Convention Kansas City August 1976 close: Ford defeated Reagan 1187-1070 first ballot. Bob Dole VP.</p> <p>Democratic primary 1976 wide-open. Carter emerged through strategic planning. Won Iowa January 19, 1976 (first major political effect of Iowa caucuses). Won New Hampshire February 24, 1976. Won March 9 Florida against Wallace.</p> <p>Democratic Convention NY July 12-15, 1976 nominated Carter. Walter Mondale VP.</p> <p>Carter campaign: trust + character + outsider. "I will never lie to you."</p> <p>Ford campaign: incumbency + foreign-policy experience.</p> <p>October 6, 1976 second debate: Ford "no Soviet domination of Eastern Europe" gaffe. Ford refused to retract for 6 days.</p> <p>Carter 297 EV; Ford 240. Carter 23 states + DC; Ford 27 states. Margin 1,683,247</p>

popular votes.

Carter's coalition: restored Solid South except VA + Northeast except much New England + industrial Midwest + Hawaii. Ford coalition: West Coast + Mountain West + rural Midwest + most New England + Virginia.

Carter inaugurated January 20, 1977. Achievements: Camp David Accords September 1978; Panama Canal Treaties 1977-78; China normalization January 1979; Department of Energy August 1977; Department of Education October 1979; deregulation (Airline 1978, Motor Carrier 1980, Staggers Rail 1980); SALT II June 1979 (signed but unratified after December 1979 Soviet invasion of Afghanistan).

Carter presidency damaged by three crises: (1) Stagflation continued - inflation 13.5% (1980). (2) November 4, 1979 Iran hostage crisis - 52 American hostages 444 days. April 24, 1980 Operation Eagle Claw rescue failed (8 deaths). (3) July 15, 1979 "malaise speech" - "crisis of confidence."

1980 election (Reagan 489-49 EV) = landslide defeat. Carter first incumbent president to lose since Hoover 1932.

1976 election structural significance: (1) Post-Watergate Americans wanted outsider trust. (2) Carter rebuilt Democratic Southern coalition McGovern 1972 had failed. (3) Structural inflection point between post-WWII Democratic dominance (1932-80) and Reagan-era Republican-conservative ascendance (1980-2008).

The Carter 1976 victory was the structural template for subsequent post-scandal outsider candidates: Reagan 1980 (post-Carter "malaise"); Bill Clinton 1992 (post-Bush recession); Obama 2008 (post-Bush Iraq + 2008 financial crisis); Trump 2016 (post-Obama "deplorables"). The "outsider after scandal" framework would dominate U.S. presidential politics through the 21st century.

The 1976 election can be analyzed retrospectively as a brief Democratic interlude in the long Republican-conservative ascendance 1968-2008. Republicans won the presidency in 1968, 1972, 1980, 1984, 1988, 2000, 2004 (7 of 11 elections); Democrats won 1976, 1992, 1996, 2008 (4 elections). The Republican coalition - Southern realignment + Western + suburban-Northeast + religious conservative - was structurally larger than the post-McGovern Democratic coalition. Carter 1976 + Clinton 1992/96 + Obama 2008 represented partial breaks rather than fundamental realignments. The structural Democratic recovery would not come until Obama 2008 + 2012 + the post-2008 demographic shifts (younger voters; college-educated suburban voters; minority voters). Then review the Key Terms on the background page so students share vocabulary before the primary-source work.

15 min **Primary source** Read the excerpt aloud once. Students annotate individually (3 min), then pair-share on worksheet questions 6 and 7 (5 min).

15 min	Discussion	Small groups (3–4). Pick one of the three prompts at the back of this packet (or assign one). Each group reports back two sentences.
20 min	Assessment	Student worksheet. Seven questions, mixed format (5 about the reading, 2 about the primary source). Answer key in the instructor section at the back.

Inaugural Address

JIMMY CARTER, JANUARY 20, 1977

Carter delivered his inaugural address from the East Portico of the U.S. Capitol on January 20, 1977.

"For myself and for our Nation, I want to thank my predecessor for all he has done to heal our land. The American dream endures. We must once again have full faith in our country - and in one another. I believe America can be better. We can be even stronger than before. Let our recent mistakes bring a resurgent commitment to the basic principles of our Nation, for we know that if we despise our own government we have no future. Because we are free we can never be indifferent to the fate of freedom elsewhere. Our moral sense dictates a clearcut preference for those societies which share with us an abiding respect for individual human rights. We do not seek to intimidate, but it is clear that a world which others can dominate with impunity would be inhospitable to decency and a threat to the well-being of all people. The world itself is now dominated by a new spirit. Peoples more numerous and more politically aware are craving and now demanding their place in the sun - not just for the benefit of their own physical condition, but for basic human rights."

Carter's background: peanut farmer, Naval officer, born-again Southern Baptist, Georgia Governor, outsider never served in Washington. "Jimmy Who?" Time magazine cover June 1976.

QUESTION 4

Ford's pardon damaged 1976 campaign: approval fell 71%'49%; "deal" allegations; trust deficit; liberal Democratic mobilization; narrow election margin where small swings could have flipped result.

QUESTION 5

Carter's "I want to thank my predecessor" inaugural opening uses three rhetorical strategies: magnanimous reconciliation, implicit Watergate-era closure, bipartisan respect. Political function: position Carter's presidency as fresh start rather than continuation of partisan conflict.

QUESTION 6

Carter's 1976 victory was the last successful Democratic Southern Democratic strategy. Carter carried 10 of 11 former Confederate states (lost only Virginia). The structural mechanism: (1) Carter's Georgia roots + born-again Southern Baptist + Southern speech patterns established cultural connection with white Southern voters. (2) Civil rights moderation - Carter had integrated Georgia government as governor but wasn't identified with Northern liberal civil rights activism. (3) Watergate aftermath - Republican Party damaged by Nixon scandals; Southern voters who had voted for Nixon 1972 could be reclaimed by sympathetic Southern Democrat. (4) Bicentennial-era nostalgia + outsider trust appeal. Subsequent Democratic strategists attempted to replicate Carter's Southern strategy. Bill Clinton 1992 (Arkansas Governor) + Bill Clinton 1996 carried some Southern states (Arkansas, Tennessee, Louisiana, Kentucky, West Virginia, Florida - varied by year) but not 10 of 11. Al Gore 2000 (Tennessee senator + Carter's former student at Carter Library) lost his home state of Tennessee to Bush. From 2000+ Democrats have not won Southern states except Florida (some years), Virginia (2008+), North Carolina (2008 only), Georgia (2020 only). The 1976 Carter Southern coalition was structurally unique - the post-Civil-Rights-Act Solid South was structurally Republican by 1980, and Carter's 1976 success was the last successful interruption. The structural lesson: Carter 1976 was the political end of the Democratic Solid South.

QUESTION 7

Carter states (23 + DC): Solid South except VA + Northeast except much New England + industrial Midwest + Hawaii. Ford states (27): West Coast + Mountain West + rural Midwest + most New England + Virginia. Geographic pattern reveals: (1) Carter restored Democratic Southern coalition. (2) Last successful Democratic Southern strategy. (3) Ford's 27 states + 240 EV demonstrated structural Republican Western + Mountain + suburban-Northeast coalition that Reagan 1980 would expand into 489-49 landslide. (4) 1976 map was structural inflection point between post-WWII Democratic dominance and Reagan-era Republican-conservative ascendance.

Discussion prompts

- 1** Carter restored Democratic Solid South coalition that McGovern 1972 had failed to mobilize. Identify three structural reasons a Southern Democratic candidate could restore the coalition that a Northern liberal candidate could not.
- 2** Ford's "no Soviet domination of Eastern Europe" October 1976 debate gaffe is widely cited as a structural cause of his 1976 loss. Identify three structural reasons televised debate gaffes can structurally damage incumbent presidents.
